



We would like to take this opportunity to announce to all of you about the progress of CWEA moving forwards after the “CWEA Sisterhood Mentoring Walk – Global Event”, that we celebrated synchronized with other different countries last November 2013. (see CWEA page on Facebook)

Now, with the support of our partners, CWEA is on the progress of finalizing the following;

## **(1) “3 years Strategic Plan” that will help members to**

- a) Ensure a high rate of business survival.
- b) Give impact in terms of job creation, improving the value chain in the country through nurturing high growth companies;
- c) Assist to ensure the sustainability of businesses by attracting the right “business match” with your “business needs”, assist in the business development programmes, networking events, access to market, promotion of your company and most of all conduct business related practical trainings that will help develop businesses.
- d) Access to business services and business mentoring to minimize initial investment and overhead costs by utilizing support services. There will be available volunteers and consulting services in the most critical situation that would need immediate answers in CWEA office and / or Sisterhood Business Mentoring Walk.
- e) Access to expert business volunteers that will provide counseling to members.
